Liberty Protection Safeguards due to be implemented October 2020

Over 600 people attended our LPS briefing sessions with Tim Spencer-Lane during the Summer and we hope that you enjoyed these and found them informative. We are considering running a few more in the Summer of 2020 once the Regulations and Code of Practice have been published. We have a page on our website dedicated to up-to-date LPS information; you may like to bookmark it and return to it regularly.

The main points to note at present are:

- Draft Regulations, and draft Code of Practice due to be issued late 2019 for consultation
- Full versions to be published by 1st April 2020
- LPS due to be implemented 1st October 2020
- LPS will cover all settings, and all people aged 16 or over

Please note: the timescales above are not fixed in stone. They may be subject to some movement. Of course the General Election may affect the schedules, but it is unlikely that anything can be decided for sure yet.

If you wish to discuss your training needs regarding LPS please give us a call, or reply to this newsletter. We are aware of differing advice about when to schedule training – please remember that the legislation has been passed and therefore we do know a substantial amount already about the LPS. Ultimately it's your decision when to train your staff.
