#### **Home Office Modern Slavery guidance**

Modern Slavery is of course now one of the ten recognised categories of abuse under Safeguarding Adults. And the Modern Slavery Act 2015 became law last year. The Home Office has issued a <u>leaflet in 11 different languages</u> aimed at helping victims. There is also <u>updated guidance for frontline staff</u>.
